The founders of an herbal company accused of secretly lacing pills with highly addictive cancer treatment drugs have verbally agreed to plead guilty to reduced criminal charges and pay thousands of dollars in fines rather than face jail time, a defense attorney said.

The same month, consumers were warned to avoid remaining supplies of seven other BotanicLab products because they might also be contaminated with ingredients of prescription drugs.

The Chens and Wang were charged in May with seven felony and seven misdemeanor counts of conspiring to doctor a variety of pills with prescription drugs and falsely promoting them as cancer remedies.

At a hearing this week, prosecutors and defense attorneys told a judge that a plea agreement was worked out and the

tony would allow the continued sale of PC SPES, the herbal product offered as a prostate cancer treatment. The bill passed the Assembly with a strong majority and is now in the Senate.

"The intent is to try to help people suffering from prostate cancer," said Peter DeMarco, Cox's press secretary. DeMarco said both assemblymen survived prostate cancer, though he did not know whether they used herbal products.

The case against BotanicLab dates back more than a year and centers mostly on PC SPES. The compound was marketed as a centuries-old Chinese herbal remedy that could help boost the immune system.

Its ingredients were said to be herbal derivatives including

reishi, Baikal skullcap, radostia, cyer's woad, mum, saw palmetto, San-Qi ginseng and Chinese licorice.

PC SPES became a huge success after studies on its benefits were published in respected medical journals. Charles Reinwald, chairman of the nonprofit Cancer Cure Coalition in Scarsdale, N.Y., told the Long Island newspaper Newsday last year that an estimated 10,000 U.S. men were taking the product.

But in February 2002, the state Department of Health Services found that both PC SPES and SPES contained elements of the anxiety drug Xanax and the blood-thinning drug Coumadin, which are supposed to be taken under a doctor's supervision.

State health officials asked BotanicLab to recall those two

types of pills in early 2002. The company complied, even though it contended that the products were inadvertently contaminated while being shipped from overseas. A short time later, a class-action lawsuit was filed by cancer survivors who had used PC SPES.

In June 2002, the company went out of business, saying it was devastated by the costs of the lawsuit and voluntary recall of the two drugs. That same month, the state health department warned consumers to avoid remaining supplies of seven other BotanicLab products: Arthrin, HepaStat, Neutralex, Indethacin, OA Plus, Osborn, Poma, and RA Spes. Officials warned that these also may be contaminated with ingredients available only in prescription medications.

They employ a team of copywriters instructed to create the long videos used to sell their crap products. **Dr. Leo Shub** is the central figure they hide behind with most of their prostate and male enhancement frauds. **Shub** will go along with anything as long as the payoff is to his liking. **Endo Pump's** fake story has **Shub** about to lose his wife to the office stud because **Shub** can't get an erection — but have no fear... **Dr. Shub** is here and... **BINGO** — he magically, instantly invents a natural pill to give him and all men erections.

They have been behind other frauds like **VitalFlow** and many others. They hire **Lorrain Digital** to make the lie-filled fake videos. They use a UPS store "mail drop" in Pinellas Park, Florida as a front for many of their scams — which are far more than prostate scams. They also use **Dr. Drew Sutton**, who spent eight years in prison on child pornography charges — see page 21.

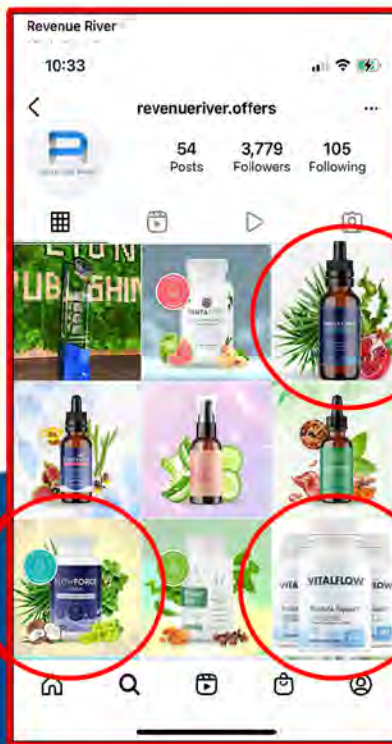
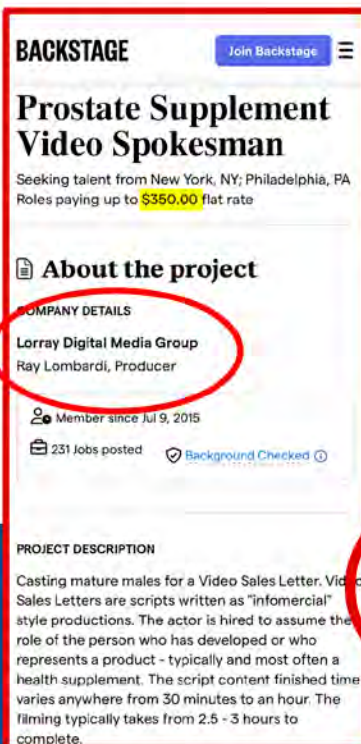
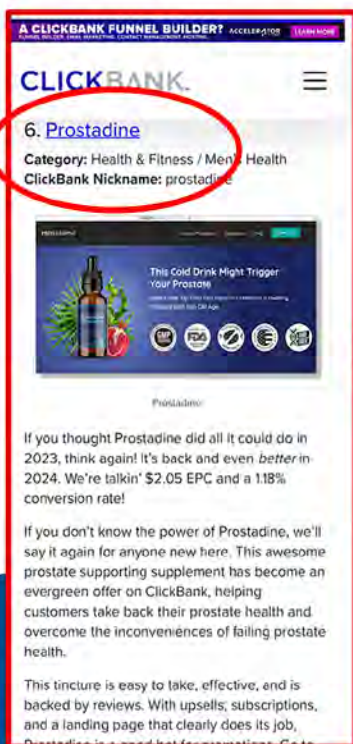

Warshak gets 25 years

Steven Warshak did more than lie to banks, hide his money and mislead thousands of customers who bought his "male enhancement" pills, a federal judge said Wednesday.

He also dragged his family and friends through a legal mess that left many of them broke and, in some cases, on their way to prison.

The judge said it's a tragedy caused by Warshak's ego and greed.

"Not only is Steve Warshak corrupt, but he corrupted members of his family and good people who worked for him," U.S.

District Judge S. Arthur Spiegel said. "He gambled with their lives. Steve Warshak was blinded by his arrogance."

Spiegel then sentenced Warshak to 25 years in prison and ordered him, his company and some members of his family to repay more than \$500 million.

The judge also sentenced Warshak's ailing, 75-year-old mother, Harriet Warshak, to two years in prison, but he agreed to let her remain free pending her appeal because of serious medical problems.

The sentences are the culmination of a federal investigation into Warshak and his

company, Berkeley Premium Nutraceuticals, that lasted at least four years and resulted in criminal charges against about a dozen employees and associates.

Most of the charges related to the sale of Enzyte, an herbal supplement that promised to boost men's sexual performance. Enzyte, the company's most popular product, was marketed on TV featuring a grinning character known as Smilin' Bob.

Prosecutors said the ads masked a criminal enterprise that involved false advertising, fraudulent bank documents, hidden profits and unauthorized charges

on customer credit cards.

The key to the scheme was Berkeley's "continuity program," which automatically charged additional orders of Enzyte to credit cards each month. The program was not fully disclosed in ads, and customers who complained were given the run-around or referred to a "quality control" officer who did not exist.

"This scheme permeated the entire operation of this company," Assistant U.S. Attorney Anne Porter said.

An examination of the current publicly available database by CR suggests that it still offers little use to consumers, a critique leveled in the inspector general's report from two decades ago.

For example, a consumer reviewing the database today might note that a product called **Super Beta Prostate** is one of **the most frequently cited supplements in CAERS, with 1,090 reports**, according to a CR review. (It's hard to know for certain which supplement has the most reports in CAERS because products with the same or similar ingredients are sometimes listed under different names.)

Marketed as an aid for men with urinary frequency problems, **Super Beta Prostate** contains an ingredient called beta-sitosterol, a substance derived from plants that is sometimes used to lower cholesterol levels but that studies suggest may also help improve urine flow in men with an enlarged prostate. The maker of the product

limited testing of the supplement to see whether it was adulterated with prescription drugs, such as tamsulosin (Flomax) and sildenafil (Viagra), which are sometimes used to treat an enlarged prostate. A drug in a supplement could interact dangerously with other medications. CR's tests didn't find those specific adulterants. Still, an examination of FDA records on **Super Beta Prostate**, obtained by CR through a Freedom of Information Act request, offers insight into how

the FDA seeks to determine whether there's a causal relationship between a product and adverse events. In 2016, records show, FDA staffers mined CAERS and detected a signal potentially tying **Super Beta Prostate** to reports of hematuria, or blood in urine, prompting the agency to investigate. But as is often the case with those reports, the data was incomplete. For example, only about a third of the **Super Beta Prostate** reports identify the consumer's age, according to CR's analysis. And documents obtained by CR



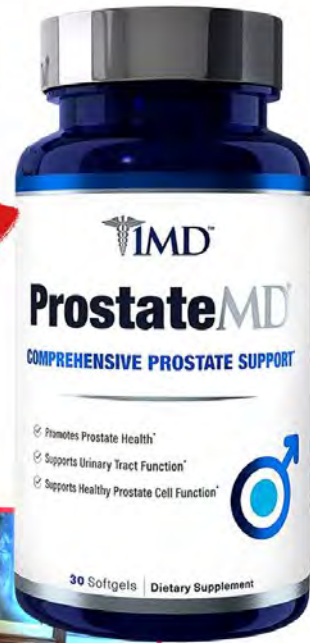
